
## Tumi Luggage Grand Prize

## **CULAC SWEEPSTAKES OFFICIAL RULES**

**NO PURCHASE OR CONTRIBUTION IS REQUIRED TO PARTICIPATE IN THE SWEEPSTAKES. OFFER VOID WHERE PROHIBITED. SUBMITTING A SWEEPSTAKES ENTRY BY ANY OF THE MEANS IDENTIFIED BELOW CONSTITUTES ACCEPTANCE OF THESE RULES.**

CULAC is the federal political action committee of the Credit Union National Association. Individual contributions to CULAC are used to support candidates who are running for federal office.

Contributions to CULAC are not tax deductible. Contributions are strictly voluntary and will be used for political purposes. You have the right to refuse to contribute without any reprisal. Making a contribution to CULAC does not increase your chances of winning.

**Eligibility:** This sweepstakes is open to individuals eligible to be solicited for CULAC and residing in the continental United States, Alaska, and Hawaii. You must be 18 years of age or older as of the date of entry in order to enter. Offer void where prohibited. Individuals located in Alabama, Arkansas, Florida, Georgia, Hawaii, Maine, Minnesota, Oklahoma, Texas, and Wisconsin are not eligible to participate. Contest is void in Alabama, Arkansas, Florida, Georgia, Hawaii, Maine, Minnesota, Oklahoma, Texas, and Wisconsin.

**Sponsor:** CULAC, located at 99 M St SE, Washington, DC 20003 is the “Sponsor” of this sweepstakes.

**Duration of Sweepstakes:** The sweepstakes begins at 12 A.M. EST on 02/26/2023 and ends at 5 P.M. EST on 03/02/2023.

**Four Methods of Entry:** No purchase or contribution is required to participate in the sweepstakes. (1) Individuals who make a contribution to CULAC between 02/26/2023 and 03/02/2023 by following the instructions located on the special CULAC [Sweepstakes website](#) are automatically entered in the drawing. (2) Individuals who make a contribution to CULAC between 02/26/2023 and 03/02/2023 by following the instructions located at the Political Affairs booth at the 2023 Government Affairs Conference are automatically entered in the drawing. (3) Existing CULAC contributors may enter the drawing by sending an email titled “ENTRY TO SWEEPSTAKES” with the participant’s name, telephone number, physical address, and e-mail address to [vseier@cuna.coop](mailto:vseier@cuna.coop) until 5 P.M. EST on 03/02/2022. (4) Individuals who are not CULAC contributors and who do not wish to contribute to CULAC at this time may enter the drawing through the same process outlined above for existing CULAC contributors. All sweepstakes entries become the property of Sponsor. Entries will not be returned. Sponsor is not responsible for entries that are lost, late, corrupted, illegible, incomplete, misdirected, or not otherwise correctly received due to technical, administrative, or human error, including, but not limited to, any software, hardware, computer or networking issues, or any other circumstances – technical or otherwise – beyond Sponsor’s control. At its sole discretion, Sponsor reserves the right to modify, suspend, or cancel this sweepstakes if it appears that the integrity, security, or administration of this process may be called into question.

**Prizes:** Prizes are shown in the “Grand Prize” and “State Prizes” section of the special CULAC [Sweepstakes website](#). The **odds of winning depend on the number of qualified entries received.** The prizes shown in any materials promoting the sweepstakes are for illustration purposes only, and the actual prizes awarded to the sweepstakes winner may differ from those shown. Making a contribution does not increase your chances of winning.

**Selection of Winners:** A daily prize winner for a state prize will be selected in a random drawing from all eligible daily entries by 12:01 A.M. EST on 02/27/2023, 02/28/2023, 03/01/2023, 03/02/2023, and 03/03/2023. The random drawing for the grand prize from all eligible entries will occur on 03/07/2023 held in private at a CUNA actual or virtual office space. The random drawings from all eligible entries for the remaining state prizes will occur on 03/06/2023 held in private at a CUNA actual or virtual office space. The daily prize winners will be notified after the daily drawing. The grand prize winner and additional state prizes winners will be notified on 03/06/2023 via email. In the event that ownership of an e-mail account is disputed, the prize will be awarded to the individual who is designated as the authorized account holder by the Internet Service Provider or other entity responsible for assigning email addresses for that domain. The prize winners will be notified at least once per business day for five (5) days beginning on the day the entry is drawn and will have seven (7) days to respond to the prize notice. If the prize winner does not respond within seven (7) days from the initial notification, then CUNA will randomly draw a new prize winner from the remaining entries and the first prize winner shall be voided. The new prize winner shall be subject to the same rules. The prize winners who notify CUNA within the required time period and accept the prize will be sent a W-9 form as applicable for the grand prize value.

**Prize Restrictions:** All taxes in connection with the prize, and the reporting consequence thereof, are the sole responsibility of the prize winner. You are only eligible to receive one prize from Sponsor per calendar year. Delivery of prize will be made in the year 2023.
